On June 9-12, 2022, CIM present the 14th annual Minnesota Irish Music Weekend At Home (MIM), a unique festival that pairs world-class traditional Irish musicians and teachers with learners of all ages for a weekend of workshops, lectures, sessions, and concerts. In June 2022, the organization launched a capital campaign to fund a leasehold improvement project.
