IN JUNE 2024, CIM PRESENTED THE 16TH ANNUAL MINNESOTA IRISH MUSIC WEEKEND (MIM), A UNIQUE FESTIVAL THAT PAIRS WORLD-CLASS TRADITIONAL IRISH MUSICIANS AND TEACHERS WITH LEARNERS OF ALL AGES FOR A WEEKEND OF WORKSHOPS, LECTURES, SESSIONS, AND CONCERTS.
